**Abstract**

*Background:* Violence is now spreading in universities, and in almost every university in Indonesia. However, the issue of sexual violence is not widely covered in the media, both electronic and social media. Therefore, education on the prevention of violence in higher education is needed, because many students become victims. *Purpose of Community Service:* Provide education to students about the prevention of violence in higher education environments in three departments: Public Sector Financial Management, Public Sector Accounting, and Digital Business at the Lombok Business Academy. Based on Permendibudristek No. 55 of 2024, PPKPT aims to create a safe, inclusive, and violence-free campus environment through education on safe reporting and assistance for victims. *Community Service Method:* The method used is to provide socialization on the prevention of violence in higher education. The result of this community service activity is to provide students with an understanding of the prevention of violence in higher education environments. *Community Service Results/Findings:* The results of this community service are so that students gain knowledge and understanding regarding the issues of violence that are rife and efforts to prevent and handle them as a form of creating a campus culture that is safe from violence and makes students feel comfortable to grow and become superior and characterful students.

### **1. INTRODUCTION**

Violence in higher education environments is increasingly prevalent on almost every campus across Indonesia. Therefore, the government, based on Permendibudristek NO. 55 of 2024, recognized PPKPT, a task force (satgas) formed in higher education to prevent and handle various forms of violence such as physical, psychological, sexual violence, bullying, and discrimination. Initially known as the PPKS (Prevention and Handling of Sexual Violence) task force, now the name has been changed to the PPKPT Task Force based on Permendikbudristek No. 38 of 2023 and strengthened in Permendikbudristek No. 55 of 2024, which has a broader scope than just sexual violence.

Violence is any act of degrading, insulting, harassing, and/or attacking a person's body and/or reproductive function, due to unequal power relations and/or gender, which results in or may result in or may result in psychological and/or physical suffering including disrupting a person's reproductive health and losing the opportunity to carry out education safely and

optimally. Based on the Law of the Republic of Indonesia Number 12 of 2022 concerning sexual violence, it is any act of other sexual violence as regulated in the law as long as it is determined in this law.

Various studies show that violence in higher education is not limited to sexual violence alone. Gelfan, Fitzgerald, and Drasgow conceptualize sexual harassment as unwanted sexual connotations committed by a person or group of people against a person consisting of three dimensions, namely gender harassment, unwanted sexual attention, and coercion. But it also includes bullying, verbal violence, discrimination, psychological violence, and even violence in the form of unfair or repressive policies.

Violence is now spreading in universities, and in nearly every university in Indonesia, yet the issue of sexual violence is not widely covered in the media, whether electronic or social. So far, the majority of sexual victims are women. Similarly, universities and campuses, once places of learning, have now become sites of numerous cases of violence.

Violence can occur anywhere, including in higher education. Findings of sexual harassment cases in higher education reinforce the three cardinal sins of education. Data from the National Committee (Komnas Perempuan) shows that the majority of sexual violence cases in education from 2015 to 2020 occurred in higher education institutions. According to data from the Ministry of Education, Culture, Research, and Technology (Kemendikbudristek), violence against women reached 2,500 cases by the end of 2021, surpassing the 2,400 cases recorded in 2020.

Violence has a profound impact on victims, both in physical, psychological, social and educational forms. From a physical perspective, victims experience hair loss and declining body condition due to decreased appetite, insomnia, digestive problems, and problems with eating patterns. Psychologically, victims experience various mental symptoms from mild to severe, such as stress, depression, revenge, trauma, to suicidal thoughts, especially if the victim is blamed by those around them. This webinar on violence in the university environment was also carried out by the acting Director General of Higher Education, Research and Technology in the webinar inviting campus residents and the public to immediately report if they experience or know of cases of violence, from these activities it is hoped that they will be able to have a positive impact on reducing the number of violence, especially sexual violence in Indonesia. This community service activity includes socialization activities on the Prevention of Violence in the University Environment in three Study Programs, namely the Public Sector Financial Management Study Program, the Public Sector Accounting Study Program, the Digital Business Study Program at the Lombok Business Academy Campus.

Through this socialization, it is hoped that students can understand violence such as physical, psychological, sexual violence, bullying and discrimination, as well as provide insight regarding the process of preventing violence in the Higher Education Environment.

## 2. RESEARCH METHOD

Community Service Activities carried out in the Higher Education Environment in Three Study Programs, namely Public Sector Financial Management, Public Sector Accounting, and Digital Business at the Lombok Business Academy campus use the Socialization method by providing an understanding to students regarding the Prevention and handling of Violence in the Higher Education Environment. This socialization is highly expected to be a form of community service by Lecturers of the Public Sector Accounting Study Program at the Lombok Business Academy in providing understanding especially to students so that students know how to protect themselves from violence in the campus environment so that the campus becomes a safe place to gain knowledge.

## 3. RESULTS AND DISCUSSION

The legal outreach program on the Prevention and Handling of Violence in Higher Education is one of the activities carried out as a manifestation of the Tri Dharma of Higher Education. This

outreach is conducted to provide the Indonesian government with the necessary support to protect victims of violence in higher education.

Violence in Higher Education is any act that demeans, intimidates, or harms the academic community (students, lecturers, and educational staff), whether physically, psychologically, sexually, or through repressive policies. This includes physical violence such as beatings and abuse; psychological violence such as intimidation, insults, and exclusion; sexual violence such as harassment and rape; bullying; and identity-based discrimination and intolerance. These acts can occur on campus or off-campus in connection with academic activities.

The Ministry of Education, Culture, Research, and Technology (Kemendikbudristek) has issued a Regulation of the Minister of Education and Culture concerning the Prevention and Handling of Violence in Higher Education Environments. This step represents the serious commitment of the Ministry of Education and Culture to prevent and handle violence in Indonesian higher education environments to ensure the fulfillment of the basic right to education for all citizens of the Republic of Indonesia. This is done as a form of realization of Article 31 of the 1945 Constitution of the Republic of Indonesia, as well as the goals of sustainable development, especially the goals regarding education and the goals regarding gender equality, by ensuring that efforts to stop sexual violence in educational units run without hindering citizens in accessing and continuing their education.

The prevention efforts undertaken are: 1) Disseminating programs and policies against sexual violence and/or bullying, both conventionally and by using information technology; 2) providing programs and budgets for the prevention of sexual violence and/or bullying; 3) increasing understanding of anti-sexual violence and/or bullying through orientation materials for introducing campus academics, lectures, seminars, discussions, public campaigns, training, and through other media, both print and electronic, as well as utilizing information technology on campus; 4) arranging safe and comfortable facilities and infrastructure; 5) encouraging the development of scientific studies and ongoing documentation on sexual violence and/or bullying based on gender priorities based on Pancasila, values and campus identity; 6) developing and improving consultation programs and legal assistance on sexual violence and/or bullying for the academic community and education staff.

Violence occurring on campus or in higher education institutions is a crime that must be eradicated. The involvement of all parties is required to participate in prevention and handling of violence on campus. Individual awareness of the impact is crucial to reducing or even eliminating violence on campus. Creating a safe and comfortable campus environment for learning is the goal of the entire academic community, so that Indonesia can become a nation with superior and moral human resources. Therefore, cooperation between all elements within the higher education environment is paramount.

This socialization activity was carried out during the PKKMB (Introduction to Campus Life for New Students) event. The moderator then acted as a guide for the socialization process. The moderator then provided an introduction to violence in the university environment. The moderator then handed over the socialization material to a lecturer from the Public Sector Accounting Study Program.



After the process of providing socialization and discussion with students of Three Study Programs, namely Public Sector Financial Management, Public Sector Accounting, and Digital Business at the Lombok Business Academy campus, it is hoped that it will increase students' understanding and knowledge about the Prevention and Handling of Violence in the Higher Education Environment.



#### 4. CONCLUSION

Violence in Higher Education is any act that demeans, intimidates, or harms the academic community (students, lecturers, and educational staff), whether physically, psychologically, sexually, or through repressive policies.
